1. Why do you want to be on the BCAS board of directors?

BCAS is at a pivotal point in its history. Marcia is retiring after 36 illustrious years as our Music Director, and David Curtis is taking the helm. With this transition, we have the opportunity to envision how we see BCAS growing in through this to have a lasting impact on BCAS for years to come! I've had the opportunity to speak with David in meetings, and he has some truly exciting ideas for our future and I would love to be given the opportunity to continue working with him and leading BCAS into the next phase of our history!

2. What are your major concerns, and how would you like to address them?

The first major concern I have is that arts organizations, in general and ours specifically, are having more difficulty attracting audiences than in the past. I will take a look at our marketing campaigns to evaluate their effect relative to their cost and reestablish/refresh consistent communication between BCAS and our audience members and the community. Additionally, since ticket sales make up the greatest part of our revenue, I plan to revive and reimagine the patron drive to attract new and returning donors as well as seek corporate donors to help us continue to produce exciting concerts for the WNY community.

Another concern is attracting and retaining younger members and audience members in order to remain current and remain one of the premier arts organizations in Western New York. One way we can do this is to evaluate our repertoire and our brand image to make sure that, from an outside perspective, BCAS is attractive to people of *all ages*. Additionally, I would like to work with David and the board about collaborating regularly with HS choruses and other community ensembles in order to help increase the awareness of BCAS in the next generation of singers and musicians.

Lastly, as with any transition, there will be both excitement and there will be bumps along the way as we transition to a new Music Director. There will be ideas and concerns from our membership as we embark on our next season. My goal will be to make sure all of these are heard and considered, and the board addresses all needs of the chorus.

3. What is your vision for BCAS during the next two years?

The first thing I see is BCAS embracing our new Music Director and exploring new and exciting ways to bring the choral art to Western New York. The current season was very successful, especially as our first season since the start of the pandemic. I see BCAS continuing that success and reaching even new heights.

I want BCAS to continue our comeback from covid through creating a strategic 5 - year plan to address our goals as an organization. A core part of this will be soliciting feedback from our members and audiences. At the end of the next two years I would like to see BCAS in an even stronger financial position that allows us the ability to present unique and innovative performances and concerts.

1. Why do you want to be on the BCAS board of directors?

I have found my first year of board membership incredibly rewarding, and I would like to continue the work we have started. I mentioned in my candidate profile for the last election that the work we do in the next year or two is going to set this choir up for potentially decades – that's not a responsibility to take lightly. I am proud of the work we did on the search committee, and I am proud of the work we've done as a board to set this transition up for success. I'm excited about the ideas we have been hearing in meetings, both in our own planning and from David. I would be honored to continue facilitating our transition as a group, and ensure member concerns or questions are addressed in a timely manner.

What are your major concerns, and how would you like to address them?

With Marcia's retirement and David coming onboard, the board will be the primary group responsible for ensuring a smooth transition. I anticipate that we will see some membership change-over – some may choose to join Marcia in her retirement, and new singers will surely join under David's direction. I have been brainstorming how we might put together a "welcome packet" for new members, as well as how we can continue to streamline communication between members & the board (in both directions!)

I am also interested in continuing to modernize our marketing and social media. Social media is a powerful (and free!) marketing vehicle to publicize our concerts and get our name out into the community. In meetings with the board, David has already shared some amazing ideas for how we can continue to utilize social media to our advantage, and I would love the opportunity to implement those ideas. Increasing our name recognition can help drive ever-important ticket sales at little-to-no cost.

A change of director is bound to bring some bumps in the road. Each member of this choir is likely going to be walking in come September with a range of different ideas, emotions, and concerns. One of my primary objectives as a board member is to ensure those voices are heard, & that the board is addressing concerns or ideas in a timely manner.

3. What is your vision for BCAS during the next year?

Aside from some pretty spectacular music, the next year is going to be transformative for our group. I have had the privilege to hear many of David's ideas, and I couldn't be more excited – it's such a wonderful blend of maintaining our traditions alongside fresh ideas. One concept David mentioned was increasing our volunteer presence in the community: it gets our name out there, and it provides opportunities for members to spend time together outside of rehearsal. In the survey Tom & I sent out in the fall, so many members said they want to get back to having more social events – I would love to see

more opportunities for those events, within the group or in the community at large.

- 1. How long have you been a member of BCAS? I have been a member of BCAS for seven years and a board member for one year.
 - 2. Describe your background and experiences relevant to BCAS?

In the past year, my primary role on the board has been as our social media manager. I have been leveraging our existing Instagram & Facebook accounts, as well as creating and managing a new TikTok account. In the last 90 days alone, our Instagram following has grown by 18 followers. In the same window, we have increased the number of interactions on Instagram posts from non-followers by 90%. Since its inception, our TikTok has gained 90 followers, 2,138 likes, and over 17,000 views on videos. I have also worked alongside Tom on some elements of publicity in tandem with our social media accounts to help drive ticket sales.

In addition to my time with the board, I also had the privilege to serve on our director search committee. The committee met several times in the fall and winter. In the fall, I collaborated with other members of the committee to create a member interest survey and analyze its results – the information from which has been invaluable in both our search and for the board at large. We interviewed several candidates, and (as you all know) ultimately offered the position to David. Prior to my tenure as a board member, I volunteered numerous times for various choir events and fundraisers, including multiple Sabres 50-50 games.

While not directly related to music, my background as an educator has certainly had transferable skills this year. As a teacher, on any given day I have upwards of 100 stakeholders to whom I am accountable — students, parents, my teammates, administrators, etc. Very often, the interests of those stakeholders are in direct conflict with one another, as well as with my goals for what needs to be accomplished within a very tight timeframe. The time management, organization, compromise, and prioritization skills I use daily as a teacher have translated well to a board position.

3. Do you have previous Board experience from any organization? Please explain.

Most recently, I served as a club advisor for Mill Middle School's drama club. In that role, I collaborated with two other colleagues to choose a musical (Mill's first in 12 years!), prepare 84 students for the audition process, conduct those auditions, and begin the rehearsal process (until tragically interrupted by COVID one month into rehearsal). In college, I was a founding member and secretary of SUNY Geneseo's chapter of Dumbledore's Army, a charity-centered international organization. While with the group, we completed multiple literature-themed events to support local and international causes, both in conjunction with and independent of the international DA organization. I was also the secretary of my high school's drama club and student director of our audition-only SATB ensemble during the year our choir took their first trip to Disney. I was responsible for running sectionals to prepare for the Candlelight Processional and assisting in ensuring 65 minors got their travel paperwork, money, and permission slips organized in a timely manner.

I envision more fundraising efforts and more publicity efforts taking place, so that we can try new things and work toward getting over the hump from people simply recognizing our name to being eager to buy tickets to our concerts without needing to hard sell all our friends and family members. I also envision more community collaboration - things like singing concerts with high school choirs, bringing composers in to work with us like we did prior to this whole pandemic, perhaps doing a staged reading of a musical with local actors, or the return of our cabaret fundraisers.

3. What is your vision for BCAS during the next year?

I think next year is going to be an exciting, but odd one for all of us. I remember the first rehearsal of the 2019-2020 season, feeling the dichotomy - the sense of "Ahh, it's good to be back," and the "This feels strange without John here." I assume that those of us who have been
